

RESOLUTION NO. 198

A RESOLUTION ADOPTING THE BUDGET FOR FISCAL YEAR 1990-91, LEVYING TAXES AND APPROPRIATING FUNDS.

BE IT RESOLVED the Aurora City Council hereby adopts the budget for Fiscal Year 1990-91, on file in the office of the City Recorder.

BE IT RESOLVED the Aurora City Council hereby levies the taxes provided for in the budget adopted in paragraph 1 of this Resolution in the aggregate amount of Seventy-Three Thousand, Four Hundred, Fifty Dollars (\$73,450.00), and that these taxes are hereby levied upon all taxable property within the City of Aurora, as of 1:00 AM, January 1, 1990.

BE IT RESOLVED the amounts for the Fiscal Year beginning July 1, 1990 to June 30, 1991, for the purposes shown below are hereby appropriated as follows:




