A RESOLUTION ADOPTING THE BUDGET FOR FISCAL YEAR 1991-92, LEVYING TAXES AND APPROPRIATING FUNDS.

BE IT RESOLVED the Aurora City Council hereby adopts the budget for Fiscal Year 1991-92, on file in the office of the City Recorder.

BE IT RESOLVED the Aurora City Council hereby levies the taxes provided for in the budget adopted in paragraph 1 of this Resolution in the aggregate amount of Seventy-Seven Thousand, One Hundred, Ninety - Three Dollars (\$77,193.00), and that these taxes are hereby levied upon all taxable property within the City of Aurora, as of 1:00 AM, January 1, 1991.




