A RESOLUTION ADOPTING THE BUDGET FOR FISCAL YEAR 1993-94; LEVYING TAXES AND APPROPRIATING FUNDS.

BE IT RESOLVED the Aurora City Council hereby adopts the budget for Fiscal Year 1993-94, on file in the office of the City Recorder.

BE IT RESOLVED the Aurora City Council hereby levies the taxes provided for in the budget adopted in paragraph 1 of this Resolution, in the aggregate amount of Eighty-Three Thousand, Eight Hundred, Twenty-Two Dollars (\$83,822.00), and that these taxes are hereby levied upon all taxable property within the City of Aurora, as of 1:00 AM on January 1, 1993.

BE IT RESOLVED the amounts for the Fiscal Year beginning July 1, 1993 to June 30, 1994, for the purposes shown below are hereby appropriated as follows:
