RESOLUTION NO. 260

A RESOLUTION ADOPTING THE SUPPLEMENTAL BUDGET FOR FISCAL YEAR 1993-94; AND APPROPRIATING FUNDS.

WHEREAS, the allocation among funds of salaries paid from more than one source were based on allocation percentages that do not accurately reflect time spent by City personnel; and

WHEREAS, more accurate allocation percentages have been calcuated which result in different personal services expenses for the General, Water Operating and Street funds; and

WHEREAS, the materials and services and capital outlay budgeted amounts in Water Operating fund should be increased and the capital outlay budgeted amount in street fund should be decreased to reflect activity in those funds; now therefore

BE IT RESOLVED BY THE AURORA CITY COUNCIL:

The Aurora City Council hereby adopts the Supplemental Budget for Fiscal Year 1993-94, on file in the office of the City Recorder.
