RESOLUTION NO. 361

APPROVING AN OCDBG GRANT CONTRACT AND AN RESOLUTION ADMINISTRATIVE SERVICES CONTRACT, AND ADOPTING A POLICY PROHIBITING THE USE OF EXCESSIVE FORCE BY LAW ENFORCEMENT AGENCIES WITHIN THE CITY AGAINST ANY INDIVIDUALS ENGAGED IN NON-VIOLENT CIVIL RIGHTS DEMONSTRATIONS AND ESTABLISH A POLICY OF ENFORCING APPLICABLE STATE AND LOCAL LAWS AGAINST PHYSICALLY BARRING ENTRANCE TO OR EXIT FROM A FACILITY OR LOCATION WHICH IS THE SUBJECT OF SUCH NON-VIOLENT CIVIL RIGHTS DEMONSTRATIONS.

WHEREAS, Oregon Economic Development Department (OEDD) has awarded \$477,500 in grant funds to the City to be used for financing sewer connections and housing repairs for low and moderate income residents of the City.

WHEREAS, the City Council of the City of Aurora desires to receive these Oregon Community Development Block Grant funds and contract with Mid-Valley Council of Government's nonprofit arm called Valley Development Initiatives (VDI) for the administration of these grant funds for the benefit of low and moderate income residents of the City.

whereas, in order to accept the grant funds, the City Council of the City of Aurora is required to adopt a policy of prohibiting the use of excessive force by law enforcement agencies within the City against any individuals engaged in non-violent civil rights demonstrations, and adopt a policy of enforcing applicable State and local laws against physically barring entrance to or exit from a facility or location which is the subject of such non-violent civil rights demonstrations with the City in accordance with Section 104(1) of the Act.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AURORA, OREGON, THAT:

Oregon Community Development Block Grant Program Grant Contract for \$477,500 in grant funds to be used for financing sewer connections and housing repairs for low and moderate income residents of the City, and the entering into a second related Administrative Services contract with Mid-Valley Council of Government's nonprofit arm called Valley Development Initiatives (VDI) for the administration of these grant funds.

<u>Section 2:</u> The City Council hereby authorizes Mayor Nick Kaiser and City Recorder Trudy Bunnell to execute and process the Grant Contract and the Administrative Services contact, subject to review and approval by Mayor Nick Kaiser and the City Attorney.

Section 3: The City Council hereby adopts a policy of prohibiting the use of excessive force by law enforcement agencies within the City against any individuals engaged in non-violent civil rights demonstrations, and adopts a policy of enforcing applicable State and local laws against physically barring entrance to or exit from a facility or location which is the subject of such non-violent civil rights demonstrations with the City in accordance with Section 104(1) of the Act.
