

RESOLUTION #88

WHEREAS, ORDINANCE No. 254 designates that water charges, fees and rates shall be reviewed annually by the City Council; and

WHEREAS, the Aurora City Council has determined it is necessary to establish water rates more consistant with present needs; now, therefore,

BE IT RESOLVED that the Aurora City Council hereby adopts the charges, fees and rates as follows:

1. The deposit to cover the cost of testing a meter at the request of the customer shall be:

5/8" - 3/4"	\$12.00	1 1/2"	\$25.00
1"	\$15.00	2"	\$30.00

2. The water service installation charges in the City of Aurora shall:

a. 3/4" service line and a 3/4" water meter - \$500  
b. 1" service line and a 1" water meter - \$550  
c. 1 1/2" service line and a 1 1/2" water meter - \$650  
d. 2" service line and a 2" water meter - \$750  
e. 2 1/2" and larger service lines and meters, the charge shall be the actual cost of labor and materials furnished by the city plus 15% of said cost for administrative and overhead expenses. Each applicant shall deposit the amount estimated by the water department with the application, and the final amount shall be adjusted after installation is completed.

3. The water connection fees in the City of Aurora shall be:


a. For a single-family dwellings, trailers, mobile or modular dwelling units - \$300  
b. For motels, hotels, apartments and other multiple-family dwellings - \$300 for the first unit and \$150 for each unit in excess of one.  
c. All other structures and facilities - \$300 plus \$30 for each 1,000 square feet of structure area, or portion thereof, in excess of 2,000 square feet.

4. The charges to be paid for city water services are as follows:
- a. The minimum charge per month shall be \$5.00 for 400 cubic feet.
  - b. Water consumed above minimum quantity allowed per month shall cost 50¢ per 100 cubic feet.
  - c. Multiple residential or commercial accounts shall pay \$5.00 per unit per month in establishing the minimum for each service. Quantity allowed shall be the number of units times 400 cubic feet.
  - d. A \$5.00 turn on fee shall be charged to all new accounts regardless of whether or not the water has been physically off. A \$5.00 turn on charge shall also be paid by accounts who have requested a temporary discontinuance of service.
  - e. A \$25.00 fee shall be charged for turning on the water after being disconnected for non-payment.


5. The charges for water service provided to residents outside the city shall be double the inside rate.

The effective date of these rates shall be July 1, 1981.
