

#### **ELECTRONIC WATER BILL PAYMENTS**

You can make payments and view your water/sewer account online at the following website <a href="https://cityofaurora.merchanttransact.com/">https://cityofaurora.merchanttransact.com/</a>. If you choose to pay your bill with a credit or debit card, there is a small convenience charge of \$3.50 for each transaction. This site also provides the option to sign up for electronic bill delivery.

## **Emergency and Non-emergency call out information**

- If you have an emergency call 911.
- If there is a non-emergency item you would like to report please call 503-588-5032, Marion County non-emergency dispatch.
- If there is a water leak that you would like to report please call City Hall, 503-678-1283. If it is after hours, please report it to Public Works at 503-444-0670 or call the non-emergency dispatch number, 503-588-5032 and they will contact public works
- The City is only responsible for repairs and water leaks in the city right-of-way, not in yards.

We understand water leaks can be concerning for various reasons. Once reported, Public Works will respond accordingly. The repairs will be prioritized according to need and scheduled for repair as soon as possible. We thank you for reporting any issues.

# CROSS CONNECTION PROGRAM Annual Testing Certification

State law requires water systems to have an approved backflow assembly if a cross connection exists with systems that can introduce contaminants into the public water system. This valve assembly will be located between the city water meter and your home or building structure. The purpose of this valve is to prevent pollutants or contaminates from entering the public potable water system. These backflow assemblies must be tested yearly by a state certified cross connection inspector. The annual testing report must be submitted to Aurora City Hall each year. There are several certified backflow valve testers in our area. You get a list from City Hall or find them here:

The following list has common examples of when back flow protection is required.

- Hose bibs without a hose bib vacuum breaker
- Irrigation or Sprinkler system
- Auxiliary water supplies (i.e. unapproved wells)
- Post mix beverage machines using carbon dioxide
- Photo developing equipment
- Chemical injectors

- Boilers
- Portable dialysis machine
- Medical equipment requiring water connection
- Swimming pools directly connected (auto-fill)
- Solar water heating systems
- Fire sprinkler systems

The Oregon Health Authority (State of Oregon) maintains a more comprehensive list. The Oregon Health Authority and the City of Aurora work to maintain a safe drinking water system. State law requires all public water systems to maintain a cross connection monitoring program. This requires that property owners with cross connection backflow valves have the unit tested annually with the inspection report maintained by the city and reported to the state agency. The city staff will work to maintain a 100% reporting standard each year, and will contact owners who have not filed their inspection report.


