Water Updates

For budgeting purposes if it is easier to pay your water bill monthly instead of bi-monthly, we here at City Hall encourage it. For example, if your bill averages about \$200.00 bi-monthly, split that in half (\$100) and pay that amount monthly. Please keep in mind that more water is used during the summer months (July/August) and less water is used during the winter months (December/January) and you may need to pay more or less monthly to accommodate that.

Any time that you pay your water bill ahead of time, it will show up as a credit on your next bill.

If you have any questions or need help figuring out your average water payment please feel free to call City Hall Water Dept at 503.678.1283.

The enclosed Utility bill is due on or before November 10th Late fees shall be assessed after the 10th as follows:

- Courtesy Notice—\$15.00
- Door Hanger/Shut off—\$45.00

Message from Aurora Fire Department

Winter's fast approaching along with the Holiday season. Here are some useful home safety tips to help prevent accidents and keep your home and families safe.

<u>Holiday decorations</u> -- If you're planning on having a live Christmas tree be sure you water it daily, and place in a stand that's designed not to tip over. If you're using an artificial tree be sure it is labeled as fire-retardant. <u>Holiday lighting</u> -- Always use lights listed by a testing laboratory. Follow the manufacture instructions on how to use the lights. Never use lit candles to decorate a tree. Also, maintain at least three feet clearance from heat sources, such as fireplaces and radiators.

<u>Smoke Alarms</u> -- When properly installed and working "SMOKE ALARMS" are the single most important means of preventing house and apartment fire fatalities by providing an early warning signal. Please test your smoke alarms monthly. Your home should have a working smoke alarm on every level including the basement. These safety tips and information provided by the **National Fire Protection Association**.
