RESOLUTION NO. 402

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AURORA, OREGON, ADOPTING THE CITY OF AURORA TRANSPORTATION SYSTEM PLAN (TSP), DATED SEPTEMBER 1999, AS THE POLICY DOCUMENT FOR ESTABLISHING GUIDELINES FOR THE CITY'S REVIEW AND DECISION OF LAND USE DEVELOPMENT APPLICATIONS AND TRANSPORTATION PLANNING AND CONSTRUCTION PROJECTS UNTIL THE CITY'S FUTURE ADOPTION OF A COMPREHENSIVE PLAN AMENDMENT, FORMALLY INCORPORATING THE TSP INTO THE CITY'S COMPREHENSIVE PLAN AND DEVELOPMENT CODE.

WHEREAS, the Oregon Transportation Planning Rule (OAR Chapter 660, Division 12) implements Statewide Planning Goal 12, Transportation, which requires the City of Aurora to develop and adopt a Transportation System Plan (TSP) to guide and direct land development and transportation projects.

WHEREAS, the City of Aurora received a Transportation and Growth Management (TGM) Grant from the Oregon Department of Transportation to complete the TSP.

WHEREAS, the City of Aurora Planning Commission has reviewed and approved the TSP.

WHEREAS, the City of Aurora anticipates that the new Wastewater Treatment System Project will create additional land development pressures and the City desires to protect the health, safety and general welfare of its citizens.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AURORA THAT:

Section 1:

The City adopts the Final Report of the Transportation System Plan (TSP), dated November 1999, as the policy document for establishing guidelines for the City's review and decision of land use development applications and transportation planning and construction projects until such time as the City can formally adopt a comprehensive plan amendment, which incorporates the TSP into the City's Comprehensive Plan and Development Code. The Planning Commission and City Council shall use the TSP as the guiding policy document to make decisions on all land use development and transportation decisions.

Section 2:

The City Council adopts this resolution to comply with the requirements of the Charter of the City of Aurora, City Ordinance No. 315, and ORS Chapter 223.
