## RESOLUTION NO. 475

# A RESOLUTION PROCLAIMING THE ANNEXATION OF CERTAIN TERRITORY AND WAIVING AN ELECTION.

WHEREAS, Lynn Kraxberger of Mar-Lyn Homes, Inc. has submitted to the City of Aurora, a written petition in the form of a land development application for annexation to the City of Aurora, signed by the owners of that real property legally described in Exhibit A attached, which exhibit is incorporated herein by this reference, and which real property is owned by STANLEY E. ANDERSON and DAWN E. ANDERSON; and

WHEREAS, notice of the proposed annexation was published twice in the Canby Herald Newspaper, and notice was also mailed to the State Department of Land Conservation and Development at least 45 days prior to the first public hearing, as well as to affected property owners and agencies; and

WHEREAS, the Planning Commission conducted the first evidentiary public hearing on October 5, 2004 and made a recommendation with conditions to the City Council, and the City Council conducted the final public hearing on October 12, 2004; and

WHEREAS, Ordinance No. <u>175</u> will be passed initiating and approving the annexation of the territory by way of public hearing before the City Council and pursuant to the applicable sections of the Oregon Revised Statutes and all applicable local requirements; and

WHEREAS, the City Council finds that annexation is in the best interest of the City and of the contiguous territory; and

WHEREAS, the City Council dispenses with an election, per ORS 222.125; now therefore,

BE IT RESOLVED, that the Aurora City Council hereby proclaims that parcel of land particularly described in Ordinance No. 475, and identified on the rolls of the Marion County Tax Assessor as Tax Map No. 041W13 Lot 600, to be annexed to the City of Aurora.

BE IT RESOLVED, that the City Recorder shall immediately submit to the Secretary of State: (1) a copy of this Resolution, dispensing with an election in the City on the question of annexation, pursuant to ORS 222.125; (2) a copy of the petition and application of the property owner of the territory annexed, and; (3) a copy of Ordinance No.475 annexing the territory. The City Recorder shall, within ten days of the effective date of annexation, submit to all applicable parties' notification of said annexation.

ADOPTED by the Aurora City Council at a regularly scheduled meeting thereof, on the 12<sup>th</sup> day of October, 2004 and effective this date.




