A RESOLUTION AUTHORIZING A NEW GARGABE COLLECTION RATE INCREASE FOR YARD DEBRIS AND COMMINGLE CART RECYCLING AND ESTABLISHING A NEW RATE SCHEDULE AND APPEALING ORDINANCE NUMBER 524.

Under Ordinance Number 439 for the City of Aurora, UNITED DISPOSAL SERVICE, INC., has exclusive franchise to provide Solid Waste Management in the City, including collecting, transporting, and conveying Solid Waste over the streets of the City, disposal of said waste, or recovery of materials or energy from said Solid Waste.

The Franchisee has applied to the City for a Rate Increase for Yard Debris and Commingled Cart Recycling and has submitted satisfactory evidence to the City Council to justify the requested Rates.

NOW, THEREFORE, BE IT RESOLVED that the maximum rates charged by UNITED DISPOSAL SERVICE, INC., in the City of Aurora shall be those Rates set forth in the attached "Exhibit A" which is incorporated by a rate sheet that is attached to this Resolution. These new Rates shall become affective after the close of business on June 1, 2007.
