
Levying Ad Valorem Taxes

BE IT RESOLVED that the City Council of the City of Aurora hereby imposes the taxes provided for in the adopted budget at the rate of 2.4849 per \$1000 of assessed value for operation and in the amount of \$260,297.00 in bonded debt: and that these taxes are hereby levied upon the assessed value as of 1:00 AM, July 1, 2007 on all taxable property within the district in the following categorization.


The above allocation and categories are broken down to show which are subject to the limits of Section 11b, Article XI of the Oregon Constitution.
