

RESOLUTION NO. 220

A RESOLUTION TO SUBMIT APPLICATION FOR 1992 SPECIAL CITY ALLOTMENT (SCA) FUNDS.

WHEREAS, under the provisions of ORS 366.800 and 366.805, there has been withdrawn from state highway funds appropriated for allocation to the several cities of the State of Oregon the sum of Five Hundred Thousand and No/100 (\$500,000.00) Dollars, and in addition there has been withdrawn from monies available to the Department of Transportation from the State Highway Fund the sum of Five Hundred Thousand and No/100 (\$500,000.00) Dollars, and said sums have been set up in a separate account to be administered by the Oregon Transportation Commission and to be allotted each year by said commission to be spent, within cities, upon streets not a part of the state highway system, which are receiving excessive wear through sudden increases in population in the area or heavy and unusual traffic; and

WHEREAS, the City of Aurora is an incorporated city of the State of Oregon and has a population of less than 5,000 as given by the latest official federal census; and

WHEREAS, the following street of said city, Ottaway Road extending west from Highway 99E NE, is not a part of the state highway system, but is a street under the jurisdiction and control of said City which is "receiving excessive wear through sudden increases in population in the area or heavy and unusual traffic; and

WHEREAS, said street is in need of repair, reconstruction, and other major improvement; and

WHEREAS, said street is a portion of an infrastructure project, funded in part by a Special Public Works Fund Grant/Loan to be repaid through special assessments; and

WHEREAS, this portion of Ottaway Road will serve as a major access to the City's Commercial and Industrial areas;


NOW, THEREFORE, the members of the Aurora City Council, in regular session assembled, do hereby find, declare and resolve:

1. That the aforementioned named street of said City is in need of repair, reconstruction and other major improvement.
2. That said street is in its present state and condition of disrepair by reason of excessive wear through sudden increases in population in the area, or by heavy and unusual traffic.
3. That the Oregon Transportation Commission is hereby respectfully requested to consider and declare said street as qualified for reconstruction, repair and other improvements out of funds allocated and made available by and through the said \$1,000,000 appropriation of revenues which is to be administered and spent by the Transportation Commission.

4. That the City of Aurora does hereby offer to the Transportation Commission and does hereby pledge complete cooperation and assistance to the end, that said City may share and participate in the use and benefit of said special fund and appropriation; and therefore does designate Heather Wechter, Street Commissioner, as the official representative of the City in all negotiations resulting from this request.

ADOPTED by the Aurora City Council at a regularly scheduled meeting thereof on Tuesday, the 25th day of June, 1991.

There is attached hereto and made a part hereof, a city map on which is indicated the street described in this Resolution.

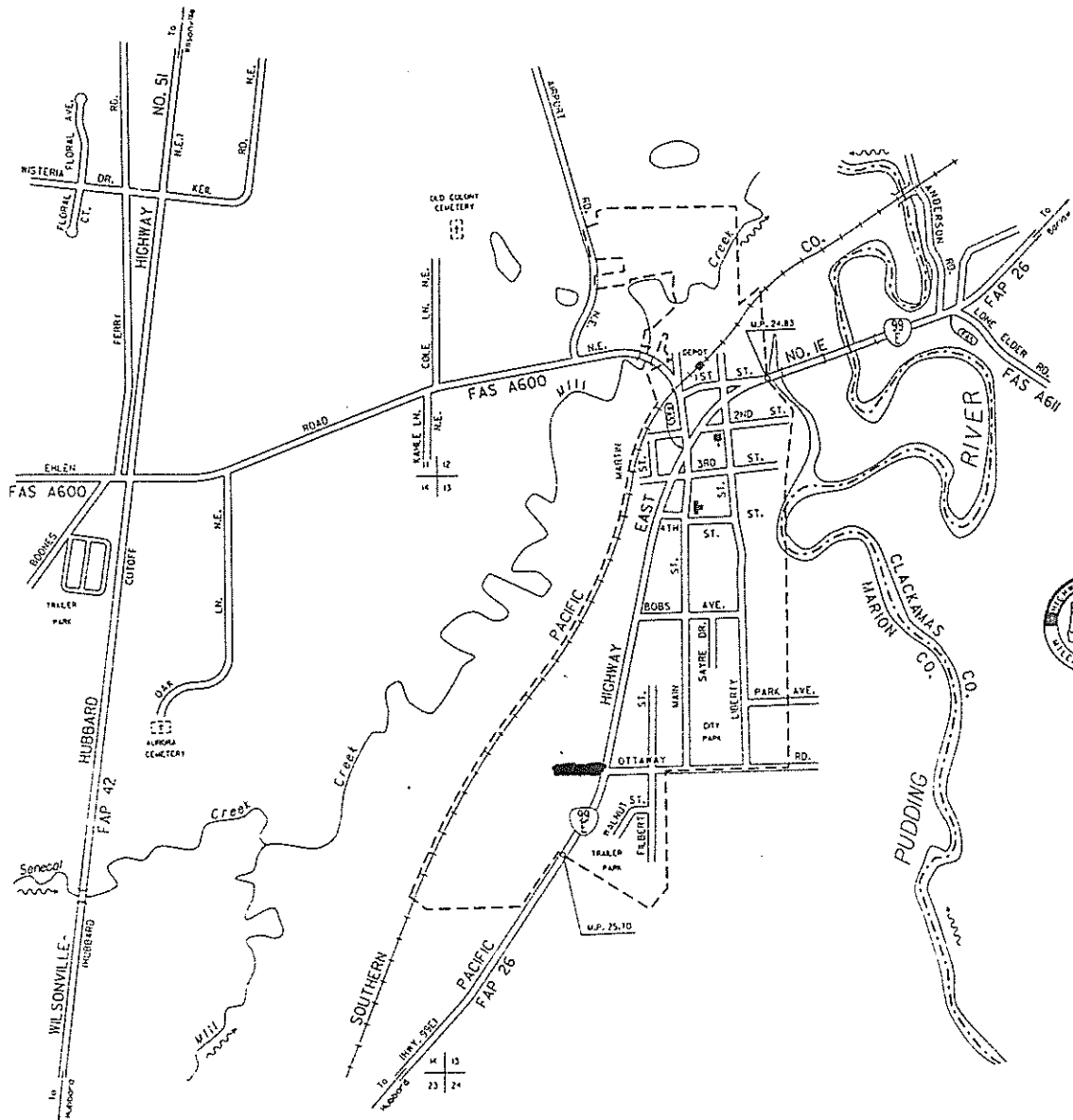

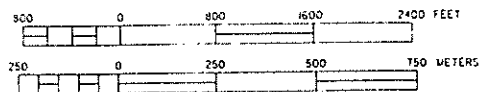
AURORA
